ACCEPTABLE PROOF OF IDENTITY <u>FOR MINORS</u> – Original or Certified Copy Required A document that establishes the parental relationship or the address of the child.
<input type="checkbox"/> Birth Certificate – Showing parents’ names
<input type="checkbox"/> Provincial Photo ID Card – Showing the address
<input type="checkbox"/> Health Insurance Card – Blue Cross, Manulife, etc. that shows the child’s name on the back
<input type="checkbox"/> Photo ID with name <u>AND</u> piece of ID with address <ul style="list-style-type: none"> ○ Passport & Blue Hospital Card with address ○ Quebec Medicare Card & Blue Hospital Card with address

ACCEPTABLE PROOF OF RESIDENCY The invoice must contain the name of the applicant or parent/legal guardian The mailing address on the documents must be the address of a partner municipality
<input type="checkbox"/> Eligibility Certificate – Must also provide a proof of identity (see above)
<input type="checkbox"/> A Utility Bill - Not older than 2 months (Ex. Phone, Internet, Electricity, Cable or Water/Sewer)
<input type="checkbox"/> Driver’s License or Provincial Photo ID Card - If not used as Proof of Identity
<input type="checkbox"/> Property Tax Bill - Mailing address must be the address of a partner municipality
<input type="checkbox"/> Residential Lease - Must be completed and signed by landlord or tenant
<input type="checkbox"/> Pay Stub - Not older than 2 months
<input type="checkbox"/> Cheque stub from a Government or Provincial Cheque - Not older than 2 months old <ul style="list-style-type: none"> ○ Examples: GST Cheque, Canada Tax Credit, Income Tax, Social Assistance

*** **Unacceptable identification:** NB Medicare Card, Social Insurance Number Card, Liquor Control Photo ID Card, Library Card, School Card, Fishing and Hunting Licenses, Credit Card, Business Card. ***
